

Woodhaven Brownstown School District Wayne County Community College Parent Statement of Confirmation



Please read thoroughly.

By submitting an application, you are requesting that your son or daughter enter the WBSD/WCCCD Early/Middle College Program and attend through grade 13. Students who are successful will graduate with a high school diploma, up to 60 college credits, an associate's degree, or any combination of these.

The purpose of the E/MC is to provide an opportunity to students who have a genuine interest in college preparedness. Students must be willing and able to succeed at the college level. Any information that is found to be incorrect or misleading may result in the student's denial of admittance into the E/MC. The ability to attend the E/MC is reviewed yearly. Students must abide by WBSD and WCCCD codes of conduct, class schedule, and calendar. **Any academic, attendance, or behavior problems will be sufficient cause to dismiss students from the program.**

Parents/guardians are critical to the success of students. Parents/Guardians of those admitted to the E/MC should be fully aware of and agree to the following:

- Students must commit to all five years of the program
- Support the attendance policy and notify the WBSD school in the event of an absence
- Provide time each day for the student to study in a quiet environment
- Review student progress regularly via WBSD ParentPortal
- Communicate with the WBSD or WCCCD staff if you have any questions or concerns
- Fully understand that E/MC is a 5-year public school program which provides the opportunity to finish high school and gain college credits
- Attend and participate in parent/teacher conferences
- Understand your child must be registered with your local school district and must inform the district of any changes in address or contact information
- Understand that any transportation not provided by the WBSD is the responsibility of the family
- Fully understand that if your student is on college campus that he/she will not be supervised before or after class. The student is responsible for his/her behavior
- Fully understand that if your student should fail an E/MC class, they will need to retake the class at your expense. Students are only allowed two failed WCCCD classes.
- Understand that the E/MC is a privilege. A criminal history or pending charges may prevent your son/daughter from successfully graduating.
