**Students who drive a motor vehicle to school must know and obey the following rules including, but not limited to:**

1. Driving privileges are extended to all students who have a Level 2 driver's license.
2. Each student must register the vehicle each school year. Registration forms can be found on our website or hard copies can be obtained in the main office. The fee is \$30 for the year or \$15 for just the second semester. There is a \$5 fee for a replacement sticker.
3. Each student must display a parking permit (in the lower corner of the windshield, driver's side) for the current year. Permits are non-transferable.
4. Each student must park only in their assigned parking spot. Student parking spots are numbered. In the event another car is parked in your spot, you should: 1) park in a non-numbered spot; and 2) report the situation to the main office.
5. Students leaving school property in a vehicle must have proper authorization.
6. Students **MAY NOT** allow another student to drive their car to and from school without prior administrative authorization.
7. Speeding or careless driving on the school grounds and on streets bordering the school is not permitted. In addition, students must abide by school policies and procedures while driving into, out of, and on school property.
8. Students who are excessively tardy for 1<sup>st</sup> hour (7 or more) may lose their parking privileges for the remainder of the semester.
9. Sitting in cars during the school day is not permitted. Students must leave cars within one minute after arriving at school.
10. Students may not go to their cars during the school day unless permission is obtained from the main office.
11. Students' cars must be locked at all times. The school district will not be held responsible for damage to or theft from cars.
12. Motorcycles, motor bikes of any type, or other non-standard motorized vehicles such as ATVs are not to be driven to school at any time.
13. Students may lose their driving privileges because of a violation of these policies and related policies in the Student Code of Conduct.
14. Reasonable searches of automobiles and students may be conducted by the administration or designated employee. (New Jersey v T.L.O., Case No. 83-172).

**Failure to comply with the rules may result in loss of parking privileges and/or vehicle being towed at owner's expense.**
